## **ANNUAL APPEAL – FALL 2022**

DEAR ISLAND FRIENDS.

I hope everyone read Emma Fernald's passionate and compelling article in the Working Waterfront in May when she made a very strong case for more affordable housing on the Cranberry Isles so that a year-round community can survive.

As Emma suggested, we need multiple solutions. Recently some summer families thoughtfully sold their seasonal homes on both islands to year-round families – likely for less money than they could have made selling to seasonal people. It would be great if more would consider this. Other helpful solutions include selling land to year-round families, renting your home to a year-round family for 11 months, or converting part of your summer home so a family can live there all year.

Cranberry Isles Realty Trust (CIRT) has been helping to develop affordable housing for over 25 years now, although we can hardly meet all needs due to lack of funds. Nevertheless, three families have lived continuously in CIRT's rental housing on Great Cranberry for about eight years now, we have one year-round rental house on Islesford that has been fully occupied, and we helped two families buy a home on Islesford, which will forever be only for year-round use. Just last summer, CIRT sold a home on Great Cranberry with similar permanent year-round covenants.

CIRT has further plans to apply for state funding that would allow us to build or renovate four or five new rental properties, providing much-needed affordable year-round housing in the Cranberry Isles community. Please see the article on the next page to learn more about this.

So, as Emma said, it's going to require a community-wide effort to make sure there is enough affordable housing on the Cranberries. It will take private home sales to year-round families, adding year-round apartments to existing homes, more year-round rental houses on both islands, financial assistance to help working families purchase houses, and much more.

#### **CIRT Developing New Rental Units**

Maine State Housing Authority (MSHA) has offered to fund up to \$210,000 per unit for new year-round rental housing on Maine's 13 unbridged islands. CIRT intends to take advantage of this opportunity by applying for funds to build (or renovate) two housing units on GCI and two or three on Little Cranberry.

On Great Cranberry, we plan to build two single-family, three bedroom rental homes on land given to us in the estate of Bruce Komusin. To do this, we will supplement \$420,000 in anticipated state money with additional CIRT funds, including the proceeds from the sale of the Rice house on GCI. The house was sold with CIRT's covenants on it, ensuring it is protected as a year-round, affordable home permanently.

On Little Cranberry, we are considering a few different options. There is town land we would like to build on, and a year-round family has offered a portion of their land for development. We are considering all options so we can capitalize on the generous MSHA grant opportunity. We would love to speak to you if you have an Islesford house you rarely use

# **Check out our CHAP**

In summer 2022, CIRT launched the **Cranberry Homes Assistance Program (CHAP),** which offers financial support to help eligible working island families purchase their own year-round home. Loans of up to \$50,000 or 80% (whichever is less) of the necessary down-payment are available. Loans will be interest-free and never have to be repaid until such time as the house is sold.
